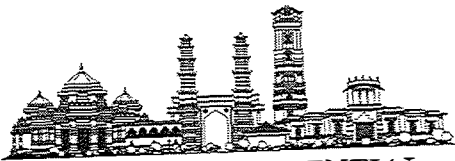

The police narrowed down on Somnath while recording statements of the neighbours during the investigation. He confessed to the crime and was booked under IPC section 302 (murder).

NOTING THAT Ahmedabad's Pirana landfill was a source of air pollution, the National Green Tribunal told the Gujarat government to deposit Rs 75 crore in an escrow account to clear the waste at the site.

A bench headed by NGT chairperson Justice Adarsh Kumar Goel said, "In view of clear and patent damage to public health, the issue of clearing the legacy waste at Pirana must be attended to preferably within two weeks and the work to clear the garbage may commence preferably within one month."

The court said after removing garbage from the entire or part of the land, the state might consider using part of the recovered land for integrated waste processing. It suggested that the land can be used for treatment, storage and disposal facility for hazardous waste, and have a bio-diversity park on the periphery to improve the air quality and ambience."

**Bharat health cards issued, 3 booked**

RAJGADH police in Panchmahals has booked three persons, including an employee of a Community Health Centre (CHC), for issuing bogus health cards under the Ayushman Bharat scheme to non BPL (below poverty line) families.

The scam was detected on June 24 at an orthopaedic hospital in Godhra. On suspicion, health officials corroborated details with the government list of beneficiaries and confirmed that the card was fake. Following an internal investigation, a formal complaint was lodged against three persons — Nilesh Rathwa, who was employed on a contractual basis at the CHC in Halol as the village level-e-gram (VLE), the data operator and finance assistant Hina Bariya and administrator of Halol Primary Health Centre Vijay Darji.  
According to the complainant Dr Minesh Doshi, health officer-in-charge of Halol-Goghamba block, the main accused Nilesh falsely provided

**inundate Surat city, trees fall in 4 locations**

HEAVY RAINFALL was recorded in two taluks of Surat city on Wednesday morning and many areas were inundated. There were also four incidents of trees getting uprooted in various localities.

The flood control department said the city received 2 inches of rainfall in just two hours, at Choryasi taluka (25 mm) and Kamrej (6 mm). However, no rainfall was reported in Navsari, Valsad, Dang, and Tapi in South Gujarat.

Weather remained foggy and temperature dipped throughout the day, providing relief from the scorching heat. The rainfall was accompanied with high-speed winds, leading to trees getting uprooted in four places and traffic jams. Fire personnel rushed to the spots and cleared the obstacles.  
Poor visibility and inundated roads caused difficulty to the people, including students. There were reports of vehicles malfunctioning due to rainwater, delaying office-goers.
