- 1) The above results have been reviewed and recommended by the Audit Committee and approved by the Board of Directors at its meeting held on 17th May, 2018 and have been audited by the statutory auditors. The financial results are prepared in accordance with the Indian Accounting Standards (IND-AS) as prescribed under Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016.
- 2) The Board of Directors, at its meeting on 17th May, 2018 have proposed a final dividend of < 0.75/- per equity share of face value < 10/- each for the financial year ender 31st March, 2018. The proposal is subject to the approval of shareholders at the Annual General Meeting to be held and if approved would result in a cash outflow of approximately < 40.18 lakh for dividend.
- 3) The Company adopted Indian Accounting Standard ("IND AS") from 1st April, 2017 and has adopted all the IND-AS standards. The adoptions were carried out in accordance with IND AS 101 First time adoption of Indian Accounting Standards. The transition was carried out from Indian Accounting Principles generally accepted in India as prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder (IGAAP) which was the previous GAAP. The impact of transition has been provided in the opening reserves as at 1st April, 2016 and periods presented have been restated accordingly.
- 4) Exceptional Item represents loss due to fire (net off insurance claim received), occurred at one of the raw material godowns of the Company on 31st August, 2016.
- 5) Consequent to introduction of Goods and Services Tax (GST) with effect from 1st July, 2017, Central Excise, Value Added Tax (VAT) etc. have been subsumed to GST. In accordance with Ind AS -18 on Revenue and Schedule III of the Companies Act, 2013, unlike Excise Duties, levies like GST, VAT are not part of Revenue. Accordingly, the figures of the period upto 30th June 2017 are not strictly relatable to those thereafter. The following additional information is being provided to facilitate such understanding:
