- 3) The Company has a single operating segment i.e. manufacturing of kraft paper (Testliner and Multilayer Testliner).
- 4) Effective 1st April, 2019, the Company has adopted Ind AS 116 "Leases", applied to all lease contracts existing on 1st April, 2019 using the modified retrospective method of transition. The effect of this adoption is insignificant on the profit for the period, earnings per share and adjustment to retained earnings.
- 5) Includes deferred tax credit of Rs. 305.88 lakh in preceding three months ended 30th September, 2019 and in nine months ended 31st December, 2019, pursuant to change in tax rate as per "The Finance (No. 2) Act, 2019".
- 6) Previous year's/quarters' figures have been regrouped wherever considered necessary to make them comparable/ conform to current year/ quarter classification.
